PROVINCIAL RESOLUTION NO. 1077-2021

AUTHORIZING THE GRANT OF LIVELIHOOD FINANCIAL ASSISTANCE TO FORTY (40) MILITIA NG BAYAN SURRENDEREES IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, the Department of the Interior and Local Government (DILG) and Department of National Defense (DND) Joint Memorandum Circular No. 01 Series of 2021 states the Implementing Guidelines on the Provision of DILG-administered Package of Assistance for Former Rebels (FRs) and Former Violent Extremists (FVEs) under the Enhanced Comprehensive Local Integration Program (ECLIP);

WHEREAS, the ECLIP's inception in 2018, several issuances were circularized to effectively implement the program such as DILG-DND Joint Memorandum Circular No. 2018-01 entitled "Implementing Guidelines for the Provision of DILG-Administrative Package of Assistance for Former Rebels (FRs) and Militia ng Bayan (MBs);

WHEREAS, as per DILG-DN JMC 01, Series of 2021 Annex A 5.5.16, the Militia ng Bayan are mass supporters or individuals who have been indoctrinated and may or may not be directly involved in the violent armed struggle but when organized, can provide mass support to the "revolutionary movement" of the CPP/NPA/NDF. These organized individuals form part of the mass base that serves as revolutionary enforcement in the barrio. They secure the NPA forces while in the community and at times, are even armed to reinforce the NPA during encounters;

WHEREAS, this Administration is committed to attaining a just, comprehensive and lasting peace under the rule of law, which is the basic foundation for economic development and national prosperity;

WHEREAS, the government shall pursue a comprehensive, integrated and community-based national program that is locally implemented to address the legal status and security of former rebels, as well as their economic, social and psychological rehabilitation needs, and provide immediate to long-term interventions that are supported by strengthened institutions to ensure effective implementation and attainment of these desired outcomes:

WHEREAS, the DILG-DND JMC 01, series of 2021 Annex B 7.1.6.2.2 states the provision of other assistance that may be determined from government agencies and other partners as convergence efforts for FRs and FVEs;

WHEREAS, in support to the government's commitment to peace and order, the Provincial Government of Pangasinan will be providing Livelihood Financial Assistance to Forty (40) individual members of ULOPAN na UMBALEY Ed Camp Gregg Military Reservation (UUECGMR) based in Bayambang, Pangasinan, a PSR listed White Area Committee 1 of the Central Luzon Regional Committee under the umbrella of Kilusang Manggagawa ng Pilipinas (KMP) who withdrawn support to the said Communist Terrorist Group (CTG) and solemnly swear their allegiance to the government;

WHEREAS, the grant of livelihood financial assistance amounting to Five Thousand Pesos each (Php 5,000.00) will serve as a start-up capital for Livelihood Projects to be awarded during their Oath of Support and Allegiance ceremony;

NOW THEREFORE, on motion of SP Member Rosary Gracia Perez-Tababa, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the grant of Livelihood Financial Assistance to Militia Ng Bayan Surrenderees in the Municipality of Bayambang, Pangasinan;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Provincial Governor, Amado I. Espino III, Provincial Treasurer, Provincial Accountant, Provincial Budget Officer and the Provincial Auditor, for their information and guidance.
