APPROVING RESOLUTION NO. 2021-259 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 6, CALENDAR YEAR 2021 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2021-259 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Development Council - Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 6 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 16, 2021 through MDC Execom Resolution No. 4, Series of 2021;

WHEREAS, said Supplemental AIP which has a total investment requirement of P5,832,574,83 covers augmentation funds for Maintenance and Other Operating Expenses (MOOE) of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the savings of the LGU as embodied in their Supplemental Budget No. 5, for FY 2021 and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2021-24 on December 9, 2021;
