APPROVING RESOLUTION NO. 2021-135 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3, CY 2021 OF SUAL, PANGASINAN AMOUNTING TO THREE MILLION SIX HUNDRED SEVEN THOUSAND NINE HUNDRED SIXTEEN & 70/100 PESOS (P3,607,916.70)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2021-135 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of Sual, Pangasinan had identified item in their Supplemental Investment Program No. 3 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on June 29, 2021 through MDC Executive Committee Resolution No. 2, Series of 2021;

WHEREAS, the said Supplemental Investment Program of the municipality with an investment requirement of P3,607,916.70, covers the “Conduct /Implementation of CBMS with DRRM and CCA Indicators”;

WHEREAS, funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 3 Series of 2021, which was passed and approved by their Sangguniang Bayan on November 22, 2021 through Appropriation Ordinance No. 04, Series of 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;


