**RESOLUTION NO. 1088-2021**

**DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF LABRADOR, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P159,574,704.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P159,574,704.00, which was enacted on October 26, 2021 through Appropriation Ordinance No. 03-2021;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the projects under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;

2. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A No. 10121 known as the as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management - National Disaster Risk Reduction and Management Council - Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
3. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. That all programs, projects and activities shall be accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated 08 March 2007;
5. That the grant of Step Increment to Elective Officials shall be in accordance with CSC-DBM JC No. 01, s-2016 dated January 27, 2016. The salary therefore of the ABC should be adjusted from SG 24/2-P404,340.00 to SG 24/1-P397,848.00;
6. That the appropriation of Representation Allowance of the Vice-Mayor shall be adjusted from P6,225.00/mo. to P6,375.00/mo. pursuant to DBM Local Budget Circular No. 103 dated May 15, 2013; and
7. That the appropriation for devolved functions and services in FY 2022 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with the Devolution Transition Plan of the Municipality.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was




