RESOLUTION NO. 1091-2020

DECLARING ORDINANCE NO. 14, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE MANDATING ALL PERSONS IN ALL PUBLIC AREAS INCLUDING GOVERNMENT AND PRIVATE OFFICES, COMMERCIAL ESTABLISHMENTS, SHOPPING MALLS, SUPERMARKETS, PUBLIC TRANSPORTATIONS, AND PUBLIC MARKET TO WEAR FACE SHIELD (ALONG WITH FACE MASK) WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CALASIAO DURING THE PERIOD OF COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 14, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) and (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071, Re: Mandatory Wearing of Face Masks or Other Protective Equipment in Public; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of October 8, 2020; and the Department of Transportation Memorandum Circular No. 2020-04; and Provincial Ordinance No. 242-2020 (An Ordinance Requiring Public Commuters and Drivers, and Employees of Both Government and Private Offices including Commercial Establishments to Wear Face Shield (Along with Face Mask) Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Community Quarantine or Until Lifted, and Providing Penalties for Violations Thereof);

WHEREAS, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated November 23, 2020;




RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 14, S-2020 of the Sangguniang Bayan of **Calasiao**, Pangasinan, entitled “An Ordinance mandating all persons in all public areas including government and private offices, commercial establishments, shopping malls, supermarkets, public transportations, and public market to wear face shield (along with face mask) within the territorial jurisdiction of the Municipality of Calasiao during the period of community quarantine and for any extension thereof” as within the conferred powers of the Sangguniang Bayan to enact;
