RESOLUTION NO. 1092-2020

DECLARING ORDINANCE NO. 15, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “AN ORDINANCE IMPOSING CURFEW IN THE MUNICIPALITY OF CALASIAO FROM EIGHT O’CLOCK IN THE EVENING (8:00 PM) TO FIVE O’CLOCK IN THE MORNING (5:00 AM) DURING THE PERIOD OF COMMUNITY QUARANTINE PURSUANT TO EXECUTIVE ORDER NO. 0024, S-2020 OF GOVERNOR AMADO I. ESPINO III AND UNTIL THE COMMUNITY QUARANTINE STATUS OF THE MUNICIPALITY HAS BEEN LIFTED” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 15, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) and (5) (xii) of RA 7160; Provincial Ordinance No. 241-2020 (An Ordinance Amending Provincial Ordinance 237-2020, Imposing Curfew in the Province of Pangasinan from Eight O’clock in the Evening (8:00 pm) to Five O’clock in the Morning (5:00 am) During the Imposition of General Community Quarantine (GCQ) 2020, Pursuant to Executive Order No. 0024-2020 of Governor Amado I. Espino III and Until the Quarantine Status of the Province has been Lifted, by adding a “No Contest Provision” Thereof; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated November 20, 2020;


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 15, S-2020 of the Sangguniang Bayan of **Calasiao**, Pangasinan, entitled “An Ordinance imposing curfew in the Municipality of Calasiao from eight o’clock in the evening (8:00 pm) to five o’clock in the morning (5:00 am) during the period of community quarantine pursuant to Executive Order No. 0024, S-2020 of Governor Amado I. Espino III and until the community quarantine status of the municipality has been lifted” as within the conferred powers of the Sangguniang Bayan to enact;
