#### **RESOLUTION NO. 1092-2021**

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF BAYAMBANG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P699,218,002.07, OPERATIVE IN PART

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS,** the Sangguniang Bayan of Bayambang, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P699,218,002.07, which was enacted on September 27, 2021 through Appropriation Ordinance Nos. 02 & 03 respectively;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. That the full implementation of the Second Tranche Compensation Adjustment for municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 132 of the Department of Budget and Management dated January 6, 2021;
- 2. That the grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 1 s-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016;

- 3. That the Step Increment of the upgraded three (3) Nurse II positions under the office of Rural Health Unit II shall be adjusted pursuant the provisions of DBM Circular No. 2021-2 dated August 25, 2021 specifically Item No. 7.1 thereof;
- 4. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects";
- 5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2007 dated March 8, 2007;
- 6. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 7. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R. A. No. 10121 Known as the Philippine Disaster Risk Reduction and Management Act 2010 and its IRR and the Department of Budget and Management National Disaster Risk Reduction and Management Council Department of Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
- 8. That the annual appropriation for extra-ordinary expenses under the Mayor's Office shall not exceed two percent (2%) of the actual receipts derived from basic Real Property Tax in the next preceding calendar year pursuant to Section No. 325 (h) of The Local Government Code of 1991;
- 9. That the appropriation for Representation and Transportation Allowances (RATA) shall be subject to the provisions of Local Budget Circular No. 103 of the Department of Budget and Management dated May 15, 2013 specifically Item No. 9.1.1; and
- 10. That the appropriation for devolved functions and services in FY 2022 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with Devolution Transition Plan of the Municipality.
