DECLARING ORDINANCE NO. 17-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE USE OF KARAOKE AND VIDEOKE MACHINES AS WELL AS SOUND PRODUCING DEVICES WHICH TEND TO DISTURB THE COMMUNITY FROM 7:00 A.M. TO 5:00 PM. MONDAY TO FRIDAY WITHIN THE MUNICIPALITY OF SAN JACINTO DURING THIS TIME OF PANDEMIC (COVID-19)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Ordinance No. 17-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (4) (i) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
