**APPROVING MUNICIPAL RESOLUTION NO. 73-2019 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1, SERIES OF 2019 OF ANDA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 73-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019 with a total investment requirement of P9,785,682.65. This was endorsed to the Sangguniang Bayan for approval on October 2, 2019 thru MDC Resolution No. 01, S-2019 and was favorably acted upon by the Sangguniang Bayan on October 30, 2019 thru SB Resolution No. 73-2019;

**WHEREAS**, the Supplemental Investment Program No. 1 for CY 2019 of the municipality covers the fund augmentation for the personal services, and maintenance and other operating expenses of various municipal offices and implementation of development projects of the municipality;

**WHEREAS**, the development projects proposed to be funded by realigned 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled “Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects”;
