PROVINCIAL ORDINANCE NO. 110-2004

**AN ORDINANCE CHANGING THE NAME OF
DASOL MUNICIPAL HOSPITAL INTO COL.
DOMINGO A. VALDEZ MEMORIAL HOSPITAL**

WHEREAS, a resolution was duly adopted by the Municipal Health Board of Dasol requesting for the change of the name of Dasol Municipal Hospital into Col. Domingo A. Valdez Memorial Hospital;

WHEREAS, said Municipal Health Board Resolution was based on a Deed of Donation dated March 20, 1990, made and executed by and between the Municipality of Dasol represented by Honorable Ludovico R. Espinoza and Dr. Condrado Galsim, Jr., Regional Director, Department of Health;

WHEREAS, said parcel of land consisting of 20,000 square meters shall be devoted exclusively to a government hospital and be named as Col. Domingo A. Valdez Memorial Hospital as a condition to the Deed of Donation;

WHEREFORE, in view of the foregoing, on motion of SP Member Danilo B. Dizon, duly seconded, be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Changing the Name of Dasol Municipal Hospital into Col. Domingo A. Valdez Memorial Hospital".


