**APPROVING RESOLUTION NO. 2021-220 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 2<sup>ND</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2021 OF THE MUNICIPALITY OF SISON, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its SB Resolution No. 2021-220 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Local Development Council of Sison, Pangasinan has identified programs/projects to be funded from the municipality's CY 2018 and 2019 share from Tobacco Excise Tax. These are embodied in the municipality's Second Supplemental Annual Investment Program which was endorsed to the Sangguniang Bayan for approval on December 06, 2021 through MDC Resolution No. 02, Series of 2021;

**WHEREAS**, the 2<sup>nd</sup> Supplemental Investment Program which has a total investment requirement amounting to P17, 234,351.00 covers the implementation of development projects that are consistent with Local Budget Memorandum Nos. 83 and 84, both dated November 22, 2021;

**WHEREAS**, to support the implementation of the 2<sup>nd</sup> Supplemental Investment Program, the Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 03, Series of 2021 on December 13, 2021;


