RESOLUTION NO. 1100-2020

DECLARING ORDINANCE NO. 2020-11 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE USE OF KARAOKE, VIDEOS KES AND OTHER SOUND-PRODUCING DEVICES WHICH TEND TO DISTRACT THE ONLINE CLASSES AND WORK FROM HOME FROM SUNDAY TO FRIDAY AMID TO COVID-19 PANDEMIC AND PROVIDING PENALTIES THEREOF IN THE MUNICIPALITY OF SAN MANUEL, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Ordinance No. 2020-11 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii) (4) (i) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;


