APPROVING RESOLUTION NO. 110-2021 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao Pangasinan submitted its SB Resolution No. 110-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Burgos, Pangasinan had identified items in their Supplemental Investment Program No. 5 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 8, 2021 by the MDC through Resolution No. 2021-006;

WHEREAS, the Supplemental Investment Program covers implementation of development projects and COVID-19 related projects;

WHEREAS, funding support for the implementation of this Supplemental Investment Program in the amount of P3,042,960.16 is embodied in the Supplemental Budget No. 5 for Calendar Year 2021, which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 05, Series of 2021 on November 10, 2021;
