DECLARING MUNICIPAL ORDINANCE NO. 8, S-2020 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER (MUNICIPAL GOVERNMENT DEPARTMENT HEAD I), SALARY GRADE 24 IN THE MUNICIPALITY OF BINMALEY" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 8, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (1) (viii) and 443 (c) (2) of RA 7160;

WHEREAS, however, the qualifications should be revised to conform with the provisions of NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1 dated April 4, 2014, to wit:

Bachelor's Degree

Experience:

4 years in position involving management and supervision,

one year of which is relevant to DRRM

Training:

24 hours of training in management and supervision on DRRM

Eligibility:

Career Service Professional/Second Level Eligibility
