APPROVING RESOLUTION NO. 20-073 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "REALIGNING THE AMOUNT OF ELEVEN MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (P11,750,000.00) FROM PROJECT TITLED: 1) TRAINING OF EMERGENCY/RESCUE TEAM (P2,500,000.00); 2) CONDUCT OF SEMINARS AND DRILL (P1,500,000.00); 3) PROCUREMENT OF RESCUE EQUIPMENT AND RESCUE VEHICLE (P6,500,000.00); 4) CONDUCT OF FIRE, FIRST-AID AND RESCUELYMPICS (P250,000.00); 5) GAS AND VEHICLE MAINTENANCE (P800,000.00; AND 6) MISCELLANEOUS (BILLS. ETC.) (P200,000.00) TO **PROJECT** TITLED: PROCUREMENT OF ONE (1) UNIT (BRAND NEW) DOUBLE CAB RESCUE TRUCK WITH ARTICULATED RESCUE CRANE, 5-TON WINCH, TOWER LIGHT AND ACCESSORIES (P9,000,000.00) AND 2) PROCUREMENT OF INFORMATION AND COMMUNICATION (TEXT MESSAGING ALERT SYSTEM) (P2,750,000.00) IN THE **TOTAL AMOUNT OF P11,750,000.00"** 

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-073 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan proposed to the Sangguniang Panlungsod the realignment of the sum of P11,750,000.00 from the allocation of some projects identified under the 2020 Local Disaster Risk Reduction and Management Plan. This was endorsed by the Council, through CDC Resolution No. 13-20 (Series of 2020), dated September 22, 2020 to the Sangguniang Panlungsod for approval;
