**APPROVING RESOLUTION NO. 20-074 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 9 FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PANGASINAN”**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-074 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan prepared the City’s Supplemental Investment Program (SIP) No. 9 for CY 2020. This was endorsed by the Council, through CDC Resolution No. 14-20 (Series of 2020), dated October 1, 2020 to the Sangguniang Panlungsod for approval;

**WHEREAS**, said Supplemental AIP No. 9, CY 2020, which has a total investment requirement of P3,600,000.00, covers priority infrastructure projects of the LGU;

**WHEREAS**, funding for the Supplemental AIP will be sourced from the realignment of funds allocated to the following projects programmed under the 20% Development Fund, CY 2020, to wit:


