**APPROVING RESOLUTION NO. 20-075 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “REALIGNING THE AMOUNT OF THREE MILLION SIX HUNDRED THOUSAND PESOS (P3,600,000.00) FROM PROJECT TITLED: 1) CONSTRUCTION OF MULTI-PURPOSE HALL AT BARANGAY MAMARLAO (P2,251,889.00); AND 2) CONSTRUCTION OF RURAL HEALTH UNIT AT BARANGAY MAMARLAO (P1,348,111.00); TO PROJECT TITLED: 1) CONSTRUCTION OF ELEVATED WATER PUMP AT SLAUGHTERHOUSE (P612,000.00) 2) CONSTRUCTION OF RETAINING WALL AT BLISS, PAGAL (P2,748,705.00); 3) ADDITIONAL FUNDING FOR THE CONSTRUCTION OF MULTI-PURPOSE HALL AT BARANGAY PALOSPOS (P135,132.00); AND 4) ADDITIONAL FUNDING FOR THE CONSTRUCTION OF MULTI-PURPOSE HALL AT BARANGAY PARAYAO (P104,163.00)”**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-075 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan proposed to the Sangguniang Panlungsod the realignment of the sum of P3,600,000.00 from the allocation of some projects identified under the 20% Development Fund, CY 2020. This was endorsed by the Council, through CDC Resolution No. 15-20 (Series of 2020), dated October 1, 2020 to the Sangguniang Panlungsod for approval;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


