RESOLUTION NO. 1109-2020

APPROVING RESOLUTION NO. 2020-197 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-197 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 5 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 6, Series of 2020, dated October 15, 2020 to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental AIP No. 5, CY 2020 covers augmentation funds for MOOE and Capital Outlay of the LGU in the amount of P15,293,532.67. This will be sourced from the Savings/General Fund of the LGU as embodied in their Supplemental Budget No. 5, FY 2020 and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2020-08 dated October 23, 2020;

WHEREAS, the Supplemental AIP also includes Covid-19 related PPAs of the LGU in the amount of P10,300,000.00. This will be derived from the Local Government Support Fund – Covid-19 Financial Assistance to LGUs. The identified Covid-19 related PPAs were based on Local Budget Circular No. 128 dated September 17, 2020 of the Department of Budget and Management (Guidelines on the Release and Utilization of the Local Government Support Fund – Covid-19 Financial Assistance to LGUs in the Bayanihan to Recover as One Act, Republic Act No. 11494);


