RESOLUTION NO. 1110-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2021 OF STO. TOMAS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P5,511,948.48, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2021 involving total appropriations of P P5,511,948.48, which was enacted on October 19, 2021 through Appropriation Ordinance No. 01 series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- That the funding sources for the subject Supplemental Budget were determined in accordance to Section 321 of R.A. No. 7160 and Article 414 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of savings from Personal Services (PS) shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings);

- 3. That the implementation of Second Tranche Modified Salary Schedule to all municipal officials and employees shall be in accordance with the provisions of the Local Budget Circular No. 132 dated January 6, 2021 (Implementation of the Second Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to R.A. No. 11466);
- 4. That the appropriation for Other Personnel Benefits shall only be disbursed upon issuance of circular by proper authority granting the same. Otherwise the same shall be deemed bereft of legal basis; and
- That the appropriation for payment of Terminal Leave Benefits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative In Its Entirety the Supplemental Budget No.1 for Calendar Year 2021 of Sto. Tomas, Pangasinan;
