#### **RESOLUTION NO. 1112-2020**

APPROVING RESOLUTION NO. 2020-322 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2020-322 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2021 and endorsed through MDC Resolution No. 2020-06 dated August 3, 2020 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan through Resolution No. 2020-322 dated October 14, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Balungao, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other services sectors and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS),

Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Nutrition Plan, Annual Procurement Plan and Annual Cultural Development Plan, and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and to combat HIV-AIDS;

WHEREAS, the AIP of Balungao has a total investment requirement amounting to P203,299,107.15. P128,199,107.15 will be funded from the municipality's proposed 2021 Annual Budget, enacted on October 14, 2020 through Appropriation Ordinance No. 2020-04 and approved by the Municipal Mayor on October 27, 2020. The remaining amount of P75,100,000.00 is proposed to be funded by external sources (National Government Agency under Assistance to Municipality Program, LGSF and Tobacco Excise Tax;

**WHEREAS,** the development fund amounting to P21,578,961.00 which is allocated for development projects is twenty percent (20%) of the municipality's IRA (P107,894,805.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

**WHEREAS,** the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs, projects and activities of the 5% LDRRM Fund of the municipality amounting to P5,704,890.05 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, the LDRRM Plan of the municipality shall be submitted to the Office of Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management – Local Budget Memorandum No. 77 dated May 15, 2018;

**WHEREAS**, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found to be fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated July 17, 2020;
