DECLARING ORDINANCE NO. 2021-10 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE ALAMINOS CITY PUBLIC SAFETY, SECURITY, PEACE AND ORDER CODE OF 2021" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 458 (a) (1) (ii) (iii) (v) (4) (iv) (v) and (vii) (5) (v) (xiv) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2021-10 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled "An Ordinance Enacting the Alaminos City Public Safety, Security, Peace and Order Code of 2021" as within the conferred powers of the Sangguniang Panlungsod to enact;
