DECLARING **ORDINANCE** NO. 146, S-2020 SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE PHRASE "PROGRESIBONG BASISTA" AS THE OFFICIAL CATCHPHRASE OF MUNICIPALITY OF BASISTA, PANGASINAN, PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL OR UNAUTHORIZED USE THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 146, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991:
