RESOLUTION NO. 1119-2021

DECLARING ORDINANCE NO. 07-2021 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING THE EXPANSION OF THE ROSALES MUNICIPAL CEMETERY LOCATED AT BARANGAY CABALAOANGAN NORTE, ROSALES, PANGASINAN AND PROVIDING GUIDELINES FOR ITS USE, OPERATION AND MAINTENANCE, COLLECTION OF FEES AND CHARGES AND IMPOSITION OF PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 07-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (a) (b) (2) (x), 132, and 447 (a) (1)(iii) (3) (i) (4) (ix) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of public hearing and publication pursuant to Sections 187, 188 and 511 (a) of RA No. 7160;




