DECLARING MUNICIPAL ORDINANCE NO. 2018-07 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING CERTAIN PROVISIONS OF MUNICIPAL ORDINANCE NO. 2005-07 "AN ORDINANCE ESTABLISHING THE UNIVERSITY OF EASTERN PANGASINAN IN THE MUNICIPALITY OF BINALONAN, PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2018-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (a) of RA 7160 and CMO 32, Series of 2006 and CMO No. 32, Series of 2007 of the Commission on Higher Education;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the provisions of Sections 187 and 188 of RA 7160;
