RESOLUTION NO. 1121-2020

DECLARING MUNICIPAL ORDINANCE NO. 1, S-2020 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 8, CY 2018 BY AUTHORIZING THE HONORABLE MAYOR, ANTHONY C. PENULIAR OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN, TO UTILIZE THE REMAINING FUND IN THE AMOUNT OF TWENTY EIGHT MILLION FIVE HUNDRED THOUSAND PESOS (P28,500,000.00) FOR THE EXTENSION OF PUBLIC MARKET, CONSTRUCTION OF MOTORPOOL AND REINFORCED CONCRETE WALL AS PRIORITY PROJECTS OF MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Municipal Ordinance No. 1, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Officer and the Provincial Accountant, have conducted initial review and study on said municipal ordinance and found out that the aforementioned projects have been identified in the Supplemental Annual Investment Plan for CY 2019 of the municipality, with appropriations amounting to P28,500,000.00 from the loan of the LGU from the Land Bank of the Philippines, as per Sangguniang Bayan Resolution No. 52, S-2019 and approved by the Sangguniang Panlalawigan through SP Resolution No. 129-2020;

WHEREAS, however, the Municipality of Mapandan, Pangasinan is advised that the subject ordinance must be pursued in line with the provisions of RA 7160 which mandates that every loan application must comply with the requirements of the Department of Finance (Circular No. 1-2012) and the Bangko Sentral ng Pilipinas (BSP Circular No. 769, S-2012);

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 1, S-2020 of the Sangguniang Bayan of **Mapandan**, Pangasinan, entitled “An Ordinance amending Municipal Ordinance No. 8, CY 2018 by authorizing the Honorable Mayor, Anthony C. Penuliar of the Municipality of Mapandan, Province of Pangasinan, to utilize the remaining fund in the amount of Twenty Eight Million Five Hundred Thousand Pesos (P28,500,000.00) for the extension of public market, construction of motorpool and reinforced concrete wall as priority projects of Municipality of Mapandan, Province of Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
