PROVINCIAL RESOLUTION NO. 1128-2020

URGING CONCERNED LOCAL GOVERNMENT UNITS IN THE PROVINCE OF PANGASINAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY FOR THE IMPLEMENTATION OF THE BATCH REQUEST SYSTEM (BREQS) SCHEME PROGRAM

WHEREAS, the Batch Request System (BREQS) is a scheme where the Philippine Statistics Authority authorizes a partner to receive requests for PSA-issued copies of civil registry documents from the public and issue the documents to its clientele;

WHEREAS, the BREQS is a system which provides for an off-line method of encoding request for civil registry documents and its submission thereof to an on-line Serbilis Outlet;

WHEREAS, the Program aims to expedite the processing of civil registry transactions in the Province by providing a PSA service outlet for filing and releasing of PSA issued documents;

WHEREAS, it is the aim of the PSA to collaborate with local government units through the Local Civil Registry to implement the Program by receiving and servicing requests for civil registry documents not only those registered in their respective city/municipality but also those that may have been registered in other localities;

WHEREAS, the Program would provide an easier and better access to the people of Pangasinan in terms of their request for copy issuances of civil registry documents such as birth, marriage, death and Certificate of No Record of Marriage (CENOMAR);

WHEREAS, while the Program would bring the civil registration services closer to the public, it would also lessen the multitude of applicants trooping to the Philippine Statistics Authority in Calasiao, Pangasinan;

WHEREAS, at present, only eleven (11) local government units have implemented the program by entering into an agreement with the PSA for the said purpose;


WHEREAS, the Sangguniang Panlalawigan recognizing the important role of PSA is willing to help in the implementation of its programs and projects;

NOW, THEREFORE, on motion of SP Members Rosary Gracia P. Perez-Tababa, duly seconded, it was –


