**PROVINCIAL RESOLUTION NO. 1129-2020**

**INVITING DR. ANA MARIA TERESA S. DE GUZMAN, PROVINCIAL HEALTH OFFICER, AND THE FOCAL PERSON/TEAM ON BARANGAY HEALTH WORKERS OF THE SAME DEPARTMENT TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON ITS DECEMBER 14, 2020 REGULAR (WEB-BASED/ONLINE) SESSION TO UPDATE THE BODY ON THE PLANS AND PROGRAMS SPECIFICALLY FOR THE IMPLEMENTATION OF ITS GUIDELINES AND MANNER OF SELECTING RECIPIENTS FOR THE GRANT OF A FINANCIAL ASSISTANCE TO BARANGAY HEALTH WORKERS IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Province of Pangasinan recognizes the role of Barangay Health Workers as one of its vital partners in the promotion of basic health programs, projects and activities particularly in the barangays;

**WHEREAS**, in recognition of their countless sacrifice and dedicated service as frontliners in rendering primary health care services, the Provincial Government and the Sangguniang Panlalawigan have been continuously ensuring support by granting its year-end incentive to barangay health workers in the Province for the past several years, and even during this time of public health emergency crisis;

**WHEREAS**, however, the Sangguniang Panlalawigan has received reports that there are barangay health workers who are not actively and regularly performing their duties while some voluntarily render health services in the community but they are not duly accredited by its organization;

**WHEREAS**, the Sangguniang Panlalawigan firmly believes that there is a need for the concerned agencies to update the Board on the present status of all barangay health workers in the Province as well as implementation of its guidelines and manner of selecting recipients as to who should be entitled for the grant of incentive;
