**PROVINCIAL RESOLUTION NO. 1130-2020**

**REQUESTING THE SECRETARY OF THE DEPARTMENT OF JUSTICE THROUGH THE LAND REGISTRATION AUTHORITY ADMINISTRATOR TO INCLUDE THE OTHER EIGHT (8) MUNICIPALITIES OF THE 5<sup>TH</sup> DISTRICT OF PANGASINAN IN THE JURISDICTION OF THE REGISTER OF DEEDS THAT WILL BE ESTABLISHED IN THE CITY OF URDANETA**

**WHEREAS**, there are now a number of Register of Deeds in the Province of Pangasinan, particularly in Alaminos City (1<sup>st</sup> District), Lingayen (2<sup>nd</sup> District), San Carlos City (3<sup>rd</sup> District), Dagupan City (4<sup>th</sup> District) and Tayug (6<sup>th</sup> District);

**WHEREAS**, for a long period of time, there is none so far in the 5<sup>th</sup> District of Pangasinan but a Register of Deeds will soon be established in the City of Urdaneta;

**WHEREAS**, the 5<sup>th</sup> District of Pangasinan comprises other eight (8) municipalities namely: Alcala, Bautista, Binalonan, Laoac, Pozorrubio, Sison, Sto. Tomas and Villasis;

**WHEREAS**, the inclusion of the other municipalities of the 5<sup>th</sup> District in the jurisdiction of the Register of Deeds in the City of Urdaneta would be more beneficial to the people in terms of a more expeditious, economical and convenient way of service;

**WHEREAS**, the Register of Deeds in the City of Urdaneta will help decongest the heavy volume of land transactions and related businesses in the other Registers of Deeds of the Province;

**NOW, THEREFORE**, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan of Pangasinan in session assembled to request, as it is hereby requested, the Secretary of the Department of Justice through the Land Registration Authority Administrator to include the other eight (8) municipalities of the 5<sup>th</sup> District of Pangasinan in the jurisdiction of the Register of Deeds that will be established in the City of Urdaneta;


