PROVINCIAL RESOLUTION NO. 1134-2020

AMENDING BY INSERTION THE SOURCE OF FUNDS IN PROVINCIAL RESOLUTION NO. 957-2020 ENTITLED "AUTHORIZING THE GRANT OF P2,500.00 RELIEF ASSISTANCE IN KIND TO NEWLY-HIRED JOB ORDERS/CONSULTANTS/CONTRACT OF SERVICE, AND OTHER EMPLOYEES OF THE PROVINCIAL GOVERNMENT OF PANGASINAN AND A PORTION OF PUBLIC AFFAIRS FUND OF THE OFFICE OF THE PROVINCIAL GOVERNOR FOR CY 2020 WILL BE USED TO FUND THE ASSISTANCE"

WHEREAS, Section 468 (a) (1) (viii) of RA 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries, wages, allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, it is necessary to grant P2,500.00 relief assistance in kind to newly-hired Job Orders/Consultants/Contract of Service, and other employees of the provincial government to augment their basic needs during this period of public health crisis;

WHEREAS, the Provincial Government and its Officials find it meritorious to reward as a token of their dedicated service, newly-hired Job Orders/Consultants/Contract of Service, and other employees of the Province for their efforts and assistance in making Pangasinan always No. 1 in terms of public and civil service;

NOW THEREFORE, on motion of SP Members Angel M. Baniqued, Jr. and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to amend, as it is hereby amended by insertion the source of funds in Provincial Resolution No. 957-2020 entitled "Authorizing the grant of P2,500.00 Relief Assistance in kind to newly-hired job orders/consultants/contract of service, and other employees of the Provincial Government of Pangasinan and a portion of Public Affairs Fund of the Office of the Provincial Governor for CY 2020 will be used to fund the assistance";


