APPROVING RESOLUTION NO. 11-20-116 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 (SIP 4), SERIES OF 2020 OF THE LGU MABINI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 11-20-116 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Mabini, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on November 19, 2020 by the Municipal Development Council through Executive Committee Resolution No. 04, S-2020 and was favorably acted upon by the Sangguniang Bayan on November 23, 2020 thru SB Resolution No. 11-20-116;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of programs, projects and activities to address the crisis brought about by the COVID-19 pandemic, disaster risk reduction programs and gender and development projects of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P3,974,389.76. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 4, CY 2020, which was passed and approved by their Sangguniang Bayan on November 23, 2020 thru Appropriation Ordinance No. 4, S-2020;


