
DECLARING MUNICIPAL ORDINANCE NO. 2018-09 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING CERTAIN PROVISION OF MUNICIPAL ORDINANCE NO. 2011-03 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2018-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (3) (vi) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the requirements set forth in Sections 59 and 511 of RA 7160;
