APPROVING RESOLUTION NO. 142-2021 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 03 CALENDAR YEAR 2021 INVOLVING AN AMOUNT OF FOUR HUNDRED EIGHTY FIVE THOUSAND FIVE HUNDRED SIXTY NINE PESOS AND SEVENTY CENTAVOS (P485,569.70) FOR PURPOSES OF FUNDING FOR THE APPROVED POSITIONS IN VARIOUS OFFICES OF LGU-ROSALES"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its SB Resolution No. 142-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Rosales, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 3 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on October 11, 2021 through MDC Resolution No. 1011-A, S.2021;

WHEREAS, the Supplemental Investment Program No. 3 with an investment requirement amounting to P485,569.70 covers fund augmentation for the Personal Services requirement of some offices of the LGU Rosales;
