RESOLUTION NO. 1146-2020

DECLARING ORDINANCE NO. 18, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “AN ORDINANCE REQUIRING THE REGISTRATION AND LICENSING OF MUNICIPAL FISHERFOLK, FISHING VESSELS AND FISHING GEAR IN THE MUNICIPALITY OF SAN FABIAN, PANGASINAN, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 18, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 129 of RA 7160 and RA No. 10601, otherwise known as “Agricultural and Fisheries Mechanization Law”;

WHEREAS, the Sanggunian is hereby reminded, however, on the principle that prosecution of offenses for violation of ordinances is similar to that of criminal cases and special laws, where a court order is necessary to effect the penalty as laid down in Section 447 (1) (iii) of RA 7160;

WHEREAS, subject ordinance shall take effect after the legal requirements laid down in Sections 187, 188, 59 and 511 (a) of RA 7160 are complied with;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino, duly seconded, it was –
