APPROVING RESOLUTION NO. 40, S-2018 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE PROJECTS TO BE FUNDED BY THE THIRTY (30) PERCENT QUICK REACTION FUND SAVINGS FROM THE CALAMITY FUNDS OF CY-2014 TO CY-2017 OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 40, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Disaster Risk Reduction and Management Council of Villasis, Pangasinan passed a resolution adopting the projects to be funded by the 30% Quick Reaction Fund savings from Calamity Funds of CY 2014 to CY 2017;

WHEREAS, based on the NDRRMC-DBM and DILG JMC No. 2013-1 dated March 25, 2013, "Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund", Item 6.0 Policies and Procedures on the Utilization of the LDRRMF states that:

6.4 The unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMC within the next five years; *and*

6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of the revised AIP as approved by the local Sanggunian and local chief executive upon recommendation of the LDRRMC in accordance with the approved LDRRMF.

WHEREAS, the Municipality of Villasis, Pangasinan is advised that the disaster risk reduction and management projects to be funded from the municipality's 30% Quick Response Fund Savings CY 2014 to CY 2017 be integrated in the LGU's Revised AIP for CY 2018 to comply with the NDRRMC-DBM and DILG JMC No. 2013-1;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Clemente B. Arboleda, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 40, S-2018 of the Sangguniang Bayan of **Villasis**, Pangasinan, entitled "Approving the projects to be funded by the thirty (30) percent Quick Reaction Fund Savings from the Calamity Funds of CY-2014 to CY-2017 of the Municipality of Villasis, Pangasinan";
