RESOLUTION NO. 1153-2020

DECLARING ORDINANCE NO. 8, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING ORDINANCE NUMBER 5, SERIES 2019, “GRANTING FINANCIAL ASSISTANCE FOR COLLEGE STUDENTS FROM THE MUNICIPALITY OF ASINGAN, PANGASINAN IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) EACH PER SEMESTER TO FIFTEEN (15) COLLEGE STUDENTS ENROLLED AT THE PANGASINAN STATE UNIVERSITY (PSU) URDANETA, ASINGAN, STA. MARIA CAMPUSES AND FIFTEEN (15) COLLEGE STUDENTS ENROLLED AT THE URDANETA CITY UNIVERSITY (UCU)”, TO “AN ORDINANCE GRANTING FINANCIAL ASSISTANCE FOR COLLEGE STUDENTS FOR THE MUNICIPALITY OF ASINGAN, PANGASINAN IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) EACH PER SEMESTER TO SIXTY (60) COLLEGE STUDENTS REGARDLESS IF THE QUALIFIED STUDENTS DESIRE TO ENROLL AT ANY PANGASINAN STATE UNIVERSITY (PSU) CAMPUSES OR AT THE URDANETA CITY UNIVERSITY (UCU)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 8, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xi) of RA 7160; RA No. 109311, otherwise known as “Universal Access to Quality Tertiary Education Act”; and RA No. 10648, “An Act Providing Scholarship Grants to Top Graduates of all Public High Schools in the State Universities and Colleges and Appropriating Funds Therefore”;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 8, S-2020 of the Sangguniang Bayan of **Asingan**, Pangasinan, entitled “An Ordinance amending Ordinance Number 5, Series 2019, “Granting Financial Assistance for College Students from the Municipality of Asingan, Pangasinan in the amount of Five Thousand Pesos (P5,000.00) each per semester to fifteen (15) college students enrolled at the Pangasinan State University (PSU) Urdaneta, Asingan, Sta. Maria Campuses and fifteen (15) college students enrolled at the Urdaneta City University (UCU)” to “An Ordinance granting financial assistance for college students for the Municipality of Asingan, Pangasinan in the amount of Five Thousand Pesos (P5,000.00) each per semester to sixty (60) college students regardless if the qualified students desire to enroll at any Pangasinan State University (PSU) Campuses or at the Urdaneta City University (UCU)” as within the conferred powers of the Sangguniang Bayan to enact;
