**APPROVING RESOLUTION NO. 2020-329 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 7 FOR THE CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2020-329 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated and endorsed to their Sangguniang Bayan for approval the municipality's Supplemental Annual Investment Program No. 7 thru MDC Resolution No. 2020-10 dated November 17, 2020;

**WHEREAS**, the Sangguniang Bayan through Resolution No. 2020-329 dated November 18, 2020 approved the Supplemental Investment Program No. 7 of the municipality. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Investment Program with an investment requirement of P15,175,301.69 covers the implementation of development projects and fund augmentation for personal services, maintenance and other operating expenses of offices of the LGU;

**WHEREAS**, the Sangguniang Bayan enacted Supplemental Budget No. 4 thru Appropriation Ordinance No. 2020-05 dated November 18, 2020 to support the implementation of Supplemental Investment Program No. 7 of the municipality;
