
#### **RESOLUTION NO. 116-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 124-091018** SANGGUNIANG BAYAN OF VILLASIS. PANGASINAN. **ENTITLED** "AN **ORDINANCE** ESTABLISHING AND ADOPTING SET OF MEASURES AND SYSTEMS SUPPORTING MATERNAL NEONATAL AND CHILD HEALTH AND NUTRITION (MNCHN) STRATEGY OF THE DEPARTMENT OF HEALTH" AS WITHIN THE CONFERRED **POWERS** OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 124-091018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (a) (b) (2) (iii) and 447 (a) (2) (i) of RA 7160; and Administrative Order No. 2008-0029, otherwise known as "Implementing Health Reforms for Rapid Reduction of Maternal and Neonatal Mortality";

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the posting requirement pursuant to Section 59 (b) of RA 7160;
