**APPROVING RESOLUTION NO. 152-2021 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 04 CALENDAR YEAR 2021 INVOLVING AN AMOUNT OF TWENTY ONE MILLION PESOS (P21,000,000.00) SOURCED OUT FROM THE RETAINED EARNINGS OF FY 2020 AND UNDERESTIMATED INCOME OF FY 2021 FOR PURPOSES OF FUNDING THE VARIOUS PROGRAMS IN THE MUNICIPALITY OF ROSALES, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its SB Resolution No. 152-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

**WHEREAS**, the Local Development Council of Rosales, Pangasinan has formulated and endorsed the municipality’s Supplemental Investment Program No. 4 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 17, 2021 through MDC Executive Committee Resolution No. 0117, S. 2021;

**WHEREAS**, the Supplemental Investment Program No. 4 with an investment requirement amounting to P21,000,000.00 covers implementation of development projects, fund augmentation for the implementation of disaster risk reduction and management programs/projects, and maintenance and other operating expenses and capital outlay of some offices in the LGU;

**WHEREAS**, the Sangguniang Bayan enacted Supplemental Budget No. 4 through Appropriation Ordinance No. 04-2021 dated September 26, 2021 to support the full implementation of the Supplemental Investment Program No. 4 of the municipality;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Rosales, Pangasinan;


