APPROVING MUNICIPAL RESOLUTION NO. 280, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PLAN FOR CALENDAR YEAR 2020 OF SUPPLEMENTAL BUDGET NO. 5 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Resolution No. 280, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Nicolas, Pangasinan has endorsed thru MDC Resolution No. 07, S-2020 dated November 27, 2020 to the Sangguniang Bayan the approval of the realignment of the salary savings and programs/projects under the special purpose appropriation and 20% development fund to Other General Services and Improvement of Public Plaza which is embodied in the municipality's Supplemental Investment Program;

**WHEREAS**, the Supplemental Investment Program with an investment requirement amounting to P3,494,344.00 which covers the general services programs and improvement of public plaza of the municipality;

**WHEREAS**, the Sangguniang Bayan on December 17, 2020, 2020 enacted Supplemental Budget No. 5 thru Appropriation Ordinance No. 6, S-2020 to support the implementation of the Supplemental Investment Program of the municipality;
