DECLARING ORDINANCE NO. 17-01 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE MUNICIPAL BIRTHING CLINIC AND OFFICIALLY NAMING THE SAME AS RHU STA. MARIA LYING-IN, DEFINING ITS FUNCTIONS, OPERATIONS AND ADMINISTRATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
