PROVINCIAL ORDINANCE NO. 119-2005

AN ORDINANCE NAMING THE CAPITOL GROUNDS FRONTING THE CAPITOL BUILDING AS AGUEDO F. AGBAYANI PARK

WHEREAS, the late Governor Aguedo F. Agbayani is a shining aegis for his virtue as a family man, for his brilliance and intelligence as a lawyer, and for his excellence as a solon representing the First District of Pangasinan;

WHEREAS, after a dynamic career as a member of the Lower House of Congress, he was elected in 1971 as Governor of the Province of Pangasinan;

WHEREAS, the late Governor Agbayani was one of the outstanding and most prudent politicians the Province has ever had and he had served the longest term as Governor of Pangasinan from 1971 to 1986, and again from 1992 to 1995;

WHEREAS, the people of this Province revered the late Governor Aguedo F. Agbayani as the "Beloved Grand Old Gentleman of Pangasinan";



Be it enacted by the Sangguniang Panlalawigan in session assembled that:


SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Naming the Capitol Grounds fronting the Capitol Building as Aguedo F. Agbayani Park".

SECTION 2. The naming of the Capitol Grounds fronting the Capitol Building is in honor of the late Governor Aguedo F. Agbayani for his remarkable contributions to the progress and development of the Province.


SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon its approval and upon consultation with the Philippine Historical Institute as provided for under Section 13, par. (a) (5) (d) of RA 7160, otherwise known as the Local Government Code of 1991.
