WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2019-49 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Manuel, Pangasinan has formulated the municipality's Supplemental Investment Program No. 3 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 04, S-2019 dated October 18, 2019. The Sangguniang Bayan approved the Supplemental Investment Program No. 3 on October 23, 2019 thru Resolution No. 2019-49. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality with an investment requirement of P3,057,970.07 covers the fund augmentation for the Capital Outlay, loan amortization and disaster risk reduction management program of the municipality;
