RESOLUTION NO. 119-2021

DECLARING MUNICIPAL ORDINANCE NO. 101, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "OTHERWISE KNOWN AS THE FOOD FORTIFICATION ORDINANCE OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 101, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (5) (iv) of RA 7160 and RA No. 8979 (An Act Establishing the Philippine Food Fortification Program and For Other Purposes);

WHEREAS, the Sanggunian is hereby reminded on the principle that prosecution of offenses for violation of ordinances is similar to that of criminal cases and special laws, where court order is necessary to effect the penalty as laid down in Section 447 (1) (iii) of RA 7160. The only way that the penalty may be effected without need of court action is when the violator voluntarily opts to pay or comply with the penalty, in lieu of prosecution in court;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;


