DECLARING ORDINANCE NO. 9, S-2021 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) TRAINING ASSISTANT II SALARY GRADE 10 IN THE OFFICE OF MUNICIPAL SOCIAL WELFARE DEVELOPMENT (MSWD) IN THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Ordinance No. 9, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
