APPROVING RESOLUTION NO. 605, S-2020 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU MDC-EXECOM RESOLUTION NO. 08-002, SERIES OF 2020 WITH ITS CORRESPONDING PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) INCURRING A TOTAL AMOUNT OF TWO HUNDRED FIFTY SEVEN MILLION PESOS ONLY (P257,000,000.00)"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 605-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council-Executive Committee of Bayambang, Pangasinan prepared their Supplemental Annual Investment Program (AIP) No. 2 for CY 2020. This was endorsed by the Council, through MDC-Execom Resolution No. 08-002, S-2020 dated August 10, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the municipality's Supplemental AIP which has a total investment requirement of P257,000,000.00 covers the implementation of various development projects of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the proceeds of the loan of the LGU in the amount of P157,000,000.00. This is embodied in their Supplemental Budget No. 02, CY 2020 and enacted by the Sangguniang Bayan through

Appropriation Ordinance No. 02, S-2020 dated September 30, 2020. The identified projects are consistent with the Loan Agreement between the Municipality of Bayambang and the Land Bank of the Philippines. The remaining amount of P100,000,000.00 will be financed through the Public-Private Partnership for People (P4) initiative;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang;


