

WHEREAS, the Sangguniang Panlalawigan is expressing grave concern over the alarming increase of confirmed COVID-19 cases for the past weeks in the Province of Pangasinan;

WHEREAS, at present, there have been active 712 COVID-19 cases reported in various parts of the Province;

WHEREAS, recently, it has been reported also that the Province of Pangasinan was among the provinces with the most number of COVID-19 cases in the whole country;

WHEREAS, some of the issues and concerns that might crop up during the Question Hour are the following: the effectiveness and efficiency of contact tracing in the Province, causes for the non-operation of the Pangasinan Molecular Diagnostics Laboratory until now, possibility of availment of freezer wherein to hold a PUI's deceased body while awaiting the result of a swab test, and implementation of border control points;

WHEREAS, the Sangguniang Panlalawigan, in collaboration with the Inter-Agency Task Forces and the Philippine National Police, will continue to look for ways and means to enact and pass legislative measures to combat COVID-19;

WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


