APPROVING SB RESOLUTION NO. 223-2018 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CALENDAR YEAR 2018 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 223-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council Executive Committee of Mangatarem, Pangasinan had identified item in their Supplemental Investment Program No. 2 for CY 2018. This was endorsed to the Sangguniang Bayan for approval on November 21, 2018 thru MDC Execom Resolution No. 01, S-2018 and was favorably acted upon by the Sangguniang Bayan on November 27, 2018 thru SB Resolution No. 223-2018;

WHEREAS, the Supplemental Investment Program covers the project: Concreting of Local Access Road Tococ Bariker to Catarataran, proposed to be funded from their Performance Challenge Fund in 2018, an award/incentive for passing the 2018 Seal of Good Local Governance (SGLG) of the DILG amounting to P3,200,000.00;
