## PROVINCIAL ORDINANCE NO. 125-2007

### AN ORDINANCE RECLASSIFYING POSITIONS UNDER THE OFFICE OF THE PROVINCIAL TREASURER AND OFFICE OF THE PROVINCIAL VETERINARIAN

**WHEREAS**, Section 468 (a) (1) (viii) of RA No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

**WHEREAS**, the positions of Local Treasury Operations Officer I, Salary Grade 11, Office of the Provincial Treasurer; Administrative Officer IV, Salary Grade 15 and Agricultural Technician II, Salary Grade 8, Office of the Provincial Veterinarian, are now vacant;

**WHEREAS**, in the exigency of service, there is a need to reclassify the above-mentioned positions as follows:

**WHEREFORE**, in view of the foregoing, on motion of SP Members Angel G. Baniqued and Romeo H. Dadacay, duly seconded –


Be it enacted by the Sangguniang Panlalawigan in session assembled that:

**Section 2.** The position titles mentioned above shall be incorporated in the plantilla in the Offices of the Provincial Treasurer and Provincial Veterinarian;


**Section 3.** This Ordinance shall take effect upon its approval.
