APPROVING RESOLUTION NO. 103, S-2020 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) 2020 OF THE LOCAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (LDRRMC) FOR THE MUNICIPALITY OF DASOL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Resolution No. 103, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Dasol, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2020 on July 21, 2020 through MDC Resolution No. 4, S-2020;

WHEREAS, the 2020 AIP of the Municipality of Dasol was revised to integrate the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the LDRRM Council thru MDRRMC Resolution No. 04, S-2020. The LDRRMFIP includes programs, projects and activities (PPA's) which were proposed to be funded by the municipality 's realigned LDRRMF CY 2020 (P248,500.00) and unexpended balances of their LDRRMF CY's 2016-2018 (P6,245,306.95);

WHEREAS, the preparation of the Revised AIP is in accordance with Sections 6.4 and 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government;

> **WHEREAS**, the new projects included in the Revised AIP are based on the abovecited Joint Memorandum Circular (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

> **WHEREAS**, the Revised AIP 2020 of the Municipality of Dasol has now a total investment requirement of P133,547,987.76 funded from the LGU Fund;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Dasol;
