PROVINCIAL RESOLUTION NO. 128-2022

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO, III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE I FOR THE IMPLEMENTATION OF THE GOVERNMENT INTERNSHIP PROGRAM (GIP) IN THE PROVINCE OF PANGASINAN

WHEREAS, the national government has been determined in defining its role to help the local government units in the application of policies, programs and projects to generate more jobs for the youth and reduce poverty in the countryside;

WHEREAS, the Government Internship Program (GIP) is a continuing program of the Department of Labor and Employment (DOLE) that aims to provide employment to poor/indigent and young workers;

WHEREAS, the DOLE-GIP desires to give internship opportunities for Pangasinense-applicants to obtain work experience in government agencies and offices at the local and national levels;

WHEREAS, the proposed agreement between the Provincial Government of Pangasinan and DOLE-Regional Office I is executed to set forth the duties and obligations of the parties with respect to the implementation of the program in the Province of Pangasinan;

WHEREAS, for the above purpose, the Memorandum of Understanding shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and the Department of Labor and Employment – Regional Office I, represented by Regional Director Evelyn R. Ramos;

NOW THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was -


